A. BPA-H School Report-Sabina Chaar

Feb - Enrollment 355; ADA 93% gain 6/ loss 3

Following current guidelines for both schools with CDE related to school closures and implementing the executive order or the Governor. Key concern is for the students and their needs and providing them with a Distance Learning Program. Both schools are partnering with the local district for providing lunches. Communicating updates for both schools through Parent Square. Currently closed through April 13th and conversations to possibly extend. Staff is encouraged to communicate with parents via internet and phone calls. Planning for short-term and long-term Distance Learning. Are there any questions?

B. BPA-SD School Report-Sabina Chaar Feb - Enrollment 158; ADA 94% gain 3/ loss 7 Same as BPA H

C. CEO Report - Frank Ogwaro

A lot of movement with respect to the new CDE requirements and directive and guidelines by SD and Hemet health officials. The biggest challenge is Distance Learning. Hoping to adjust as we go, we are only in week two. We are closely monitoring COVID 19 with SD and H health officials. We will continue to monitor the closure and the Governor's Stay at Home orders. Facilities SD - We did receive some good news. The Architect and our Traffic Consultant have been in communication with the leads. There are no additional comments which is a verbal "okay". We need to wait now for a written confirmation.

Working on getting a one to one ratio of Chromebooks for students. Some Chromebooks are being refurbished to help during this time.

Stephanie - What is the latest on the light situation from the City? Several projects in the area would need to share the cost per the agreement. City is concerned about potential litigation related to the expense of the light. We do not have to put the light up prior to the opening of the school. We can work with the City to contribute our portion over the next few years.
